

Parish of Effingham and Fetcham – Safeguarding Guidelines

1. **Diocesan Commitment.** The Diocese of Arundel and Brighton is committed to safeguarding as an integral part of the life and ministry of the Church. Supported by and in compliance with the policies and procedures of the Catholic Safeguarding Advisory Service of England and Wales, we are striving towards a culture of safeguarding where all are safe from harm and abuse and where everyone is encouraged and enabled to enjoy the fullness of life in Jesus Christ through the prayerful, nurturing, supportive and protective endeavours of the Catholic Community, both individually and collectively.
2. The Diocese will ensure that any allegations of a safeguarding matter are responded to promptly and liaise openly with statutory authorities to support investigations, responding sensitively and compassionately to those in need, and ensuring perpetrators are held to account.
3. **The Parish** will follow the Diocesan Policy on safeguarding, set out on the Diocesan website at <https://abdiocese.org.uk/safeguarding/home>.
4. Safeguarding of children and vulnerable adults is the responsibility of everyone in the parish. Everybody who comes in contact with them has a role to play in their safeguarding and in particular (but not limited to) those involved with:
 - a. Altar Servers
 - b. Youth Group
 - c. Children's Liturgy of the Word
 - d. First Holy Communion programme
 - e. Confirmation programme
 - f. Visiting and taking Holy Communion to the sick and housebound.
5. When organising or supporting parish activities involving children or vulnerable adults all volunteers should maintain the attitude that "it could happen here" and whilst in their care children and vulnerable adults have the right to feel safe, secure and protected from harm or abuse.
6. **The Parish Safeguarding Representative** is responsible for making sure the parish is aware of the importance of safeguarding children and vulnerable adults; promoting good and safe practice, including what is appropriate and inappropriate behaviour; they decide how to administer the National Safeguarding Policies and Procedures within the parish together with the Parish Priest, and the Diocesan Safeguarding Co-ordinator.
7. **Volunteers.** The parish relies on volunteers to organise and run the many activities that take place within our parish community. To meet national Safeguarding rules all parishioners involved in such activities are expected to undergo Safeguarding checks and periodic training. The Parish Safeguarding Representative will help with the completion of all the documentation and will arrange to take copies of the required documents for the **Disclosure and Barring**

Service (DBS) checks (formerly CRB check). We appreciate that many volunteer parishioners will already have been checked for other organisations or work however the law is clear and a further check is required when seeking to volunteer in the parish.

8. Reporting Incidents, Allegations and Concerns. Volunteers are in a privileged and responsible position when working with children and vulnerable adults and, in discussions with them, may come across areas of concern. In such circumstances the volunteer has the responsibility to take appropriate action as set out in their training. They must record the issue and report it promptly to the Parish Priest, the Parish Safeguarding Representative and/or the Diocesan Safeguarding Office (see list of contacts below). If the concern relates to the Parish Priest advice should be sought direct from the Diocesan Safeguarding Officer.
